- 5.12 There is no open offer made in the target company in past.
- 5.13 There is no depository receipts of the shares issued in foreign countries by target company.
- 5.14 As on date target company complied with applicable compliances under listing agreement/LODR Regulations and no penal actions including penalties levied by stock exchange.
- 5.15 There are few instances of non-compliance with the provisions of SEBI (SAST) Regulations, 2011 by promoters of the target company, for which SEBI may initiate suitable action against the said entities.
- 5.16 Post completion of open offer, the outgoing promoters shall ceased to be part of promoter and promoter group of target company and names of outgoing promoter shall be re-classified as public subject to compliance with applicable provisions of Regulations 31A of SEBI LODR Regulations, 2015 and acquirers shall become promoter of target company.

6. OFFER PRICE AND FINANCIAL ARRANGEMENTS

6.1 Justification of Offer price

6.1.1 This Offer is pursuant to a direct acquisition.

- (a) The equity shares of the Target Company are listed on the BSE Limited ("BSE"). The equity shares of the target company are infrequently traded, in terms of the SEBI (SAST) Regulations. - (b) The Offer Price would be revised in the event of any corporate action like bonus, splits etc., where the record date for effecting such corporate action falls within 3 (Three) Working Days prior to the commencement of the Tendering Period in the Offer.
- (c) In case the Acquirers acquires or agrees to acquire whether by themselves or through PAC or with persons deemed to be acting in concert with them any shares or voting rights in the Target Company during the offer period, whether by subscription or purchase, at a price higher than the Offer Price, the Offer Price shall stand revised to the highest price paid or payable for any such acquisition and would be notified to the Public

However SEBI has initiated actions against merchant banker in past in the matter of IPO of Brooks Laboratories Limited, IPO of Shilpi Cable Technologies Limited and Open Offer of Uniply Industries Limited, however all proceedings have been disposed off and no penalty was imposed.

6.1.5 There is no regulatory actions/administrative warnings/directions subsisting or proceedings pending against Registrar to the Offer under SEBI Act, 1992 and regulations made thereunder.

6.1.6 There is no actions initiated (including administrative warning) and penalties levied by SEBI/RBI against the Registrar to the captioned offer except administrative warnings were issued against them by SEBI post inspection of their records vide letter dated 12th March, 2021. In view of said letter, the registrar have undertaken corrective action and submitted the details of same to SEBI. Post submission of their reply to SEBI, they have not received any communication from SEBI in this regard.

6.2.7 The Manager to the Offer, M/s D & A Financial Services (P) Limited, hereby confirms that firm arrangements for funds and money for payment through verifiable means are in place to fulfil the Offer obligations.

7. TERMS AND CONDITIONS OF THE OFFER

7.1 Operational terms and conditions

7.1.1 The Offer is not subject to any minimum level of acceptances from the Public Shareholders.

7.1.2 The Letter of Offer specifying the detailed terms and conditions of this offer along with the form of acceptance-cum-acknowledgement ("**Form of Acceptance**") shall be dispatched to all the Public Shareholders whose name appeared on the register of members of the Target Company as at the close of business hours on **Tuesday, October 18, 2022** ("**Identified Date**") through Electronic mode in accordance with provision of Companies Act, 2013. Further, on receipt of request from any shareholder to receive a copy of the letter of Offer in physical format, the same shall be provided.

The Letter of Offer shall be dispatched to the physical shareholders through Registered Post/Speed Post/Courier or any other mode having proof of delivery.

- 7.1.3 The Offer is subject to the terms and conditions set out in this Letter of Offer, the Form of Acceptance, the PA, the DPS and any other public announcements that may be issued with respect to the Offer.
- 7.1.4 The LoF along with the Form of Acceptance cum acknowledgement would also be available at SEBI's website, that is, www.sebi.gov.in and the Public Shareholders can also apply by downloading such forms from the SEBI's website.
- 7.1.5 This Offer is subject to the receipt of the statutory and other approvals as mentioned in paragraph 7.4 of this LoF. In terms of Regulation 23(1) of the SEBI (SAST) Regulations, if the statutory approvals are refused, the Offer would stand withdrawn.

- 7.4.3 The offer would be subject to all other statutory approvals, if any that may become applicable at a later date before the completion of the offer.

- 8.5 All the Public Shareholders who desire to tender their equity Shares under the open Offer will have to intimate their respective stock brokers ("**Selling Brokers**") within the normal trading hours of the secondary market, during the Tendering Period.
